# SCHEME AMENDMENT REPORT

Lot 5483 Park Lane, Alexander Heights is a 2,840 square metre property which is currently zoned Civic and Cultural under City of Wanneroo District Planning Scheme No. 2 (DPS 2). It was transferred to the City by the developer of this part of the Alexander Heights locality in 1981 for community purposes.

Since that time, the site has remained undeveloped, and effectively forms part of a linear public open space area comprising Alexander Heights Park and Ian Robbins Park.

The site itself was subject to a flora identification survey undertaken by City Officers in 2012. This identified 120 plants, including Banksias (62), Gum Trees (46), Spotted Gum (6), Paperbark (2), WA Christmas Tree (2), Flowering Gum (1) and Stinkwood (1).

Given that this property:

- 1. is currently indistinguishable from and effectively used as part of the Alexander Heights and Ian Robbins Parks parkland area, and that if developed, it would fragment this parkland area; and
- 2. has been assessed by the City's community facility planners who do not anticipate any future requirement for this site to be developed for a community purpose use;

at its meeting of 21 July 2015, Council resolved to rezone Lot 5483 from Civic and Cultural to Parks and Recreation (Local Scheme Reserve).
