

## FITNESS EQUIPMENT AND SEAT:

- 1. THE TYPE AND LOCATION OF FITNESS EQUIPMENT PIECES SHOWN (ABOVE RIGHT, BY MIRACLE RECREATION EQUIPMENT) ARE PROVIDED AS A GUIDE ONLY, AN EXAMPLE OF THE TYPE OF EQUIPMENT TO BE CONSIDERED. ALTERNATIVE PLACEMENTS AND PIECES SHALL BE CONSIDERED PROVIDED THEY SATISFY THE SPECIFIED CRITERIA. CHANGES TO THE SOFTFALL FOOTPRINT ARE PERMITTED BUT MUST BE CLEARLY SHOWN IN THE SUBMISSION WITH PLANS INCLUDING DIMENSIONS.
- 2. THE EQUIPMENT IS TO BE SPECIFICALLY SUITED FOR SENIORS AND SHOULD BE A MINIMUM OF SIX PIECES OF FITNESS EQUIPMENT. THE EQUIPMENT MUST BE ACCESSIBLE FOR PEOPLE OF ALL ABILITIES AND TARGET A VARIETY OF MUSCLE GROUPS WITH VARYING LEVELS OF DIFFICULTY FOR PROGRESSION PURPOSES. THE EQUIPMENT SHOULD CATER FOR LOW INTENSITY EXERCISES THAT HELP IMPROVE BALANCE, FLEXIBILITY AND MOBILITY, AND REDUCE THE RISK OF FALLS FOR USERS. ALL EQUIPMENT SHOULD INCLUDE INSTRUCTIONAL SIGNAGE, PREFERABLY INCORPORATED ON THE EQUIPMENT. PLEASE INCLUDE IN YOUR SUBMISSION DETAILS OF HOW THE EQUIPMENT CAN BE USED AND DISPLAY HOW THE EXERCISES CAN BE VARIED TO OFFER EXERCISE PROGRESSION.
- 3. PREFERENCE SHALL BE GIVEN FOR ITEMS THAT PROVIDE MULTIPLE USAGE OPPORTUNITIES SO PLEASE INCLUDE A DESCRIPTION OF EXERCISES AVAILABLE. MOVABLE EQUIPMENT DOES NOT NEED TO BE INCLUDED BUT IF INCLUDED SHALL BE WITH CONSIDERATION OF ROBUST NATURE AND LIMITED MAINTENANCE REQUIREMENTS.
- 4. SPECIAL CONSIDERATION SHOULD BE GIVEN TO FINISHES AND PARTS DURABILITY. WARRANTIES FOR ALL THE EQUIPMENT INCLUDING MOVING PARTS SHOULD ALSO BE INCLUDED WITHIN THE SUBMISSION AND WILL FORM PART OF THE ASSESSMENT CRITERIA.
- 5. SEAT (OPTIONAL ITEM) : THE SEAT SHOULD BE 1.8M LONG AND BE OF A SIMILAR APPROVED DESIGN TO THAT SHOWN .
