

## Living & Leisure Expo ft. Dogs Breakfast 2015

### Terms and Conditions

1. This Competition is a promotion run by the City of Wanneroo ("Promoter"), and Matt and Kim ("Judges").
2. Entries and information on Prizes and how to enter form part of these Terms and Conditions.
3. Participation in this Competition constitutes acceptance of these Terms and Conditions.
4. Employees of the Promoter are ineligible to enter.
5. Entry to this Competition is open to the general public who submit a photo of their home or room they have renovated either to the City via 'events@wanneroo.wa.gov.au', or by posting their photo to the City's Facebook page (facebook.com/cityofwanneroo). Entries will also be accepted physically (hard copy photos) by submitting the entry to Matt and Kim at the Living & Leisure Expo ft. Dogs Breakfast at their marquee between the times of 11am and 12.30pm.
6. Photos must be received on or before 12.30pm WST on Sunday 25 October 2015 to be eligible. No responsibility is accepted for late, lost or misdirected entries.
7. The Competition commences Monday 12 October 2015 and closes at 12.30pm WST on Sunday 25 October 2015 ("Competition Period"). The Competition winner will be announced by Matt and Kim on stage at 12.30pm at Kingsway Regional Sporting Complex at the event 'The Living & Leisure Expo ft. Dogs Breakfast'.
8. One winner will be selected by Matt and Kim and judged on the quality of their renovation job from their entry.
9. The Promoter's decision in relation to all aspects of this Competition is final and binding on all who enter and no correspondence will be entered into.
10. The Winner will be required to attend the Living & Leisure Expo to redeem their prize and collect their prize from the stage at 12.30pm.
11. The top 3 finalists will be contacted prior to the event to ensure their attendance at the event to collect the prize, should they be the winner.
12. The Prize consist of a total value of \$2,500 and comprise of ("Prize"):
  - a. One two hour 'masterclass' with Matt & Kim at the winner's home. Matt and Kim will provide the winner with tips and tricks of the trade and teach them how to better renovate their home.
13. Prize components may alter at the discretion of the Promoter. The Promoter will not be liable for any change in the value of any Prize between the date the competition commences and the date the winner is announced. Prizes are not transferable, refundable or redeemable for cash.

16. If a Winner cannot attend or send a representative to the event to collect their prize, they will forfeit their Prize and it will be redrawn upon the conclusion of the event from the top 3 finalist pool. Competition results will be published on the City of Wanneroo's website and Facebook page.
17. The Promoter will rejudge the entrants to award a Prize until a suitable Winner has collected their prize. The Winner must collect their Prize by 1 December or it will be judged forfeited.
18. The Promoter will not be liable for any delivery or travel costs associated with claiming a Prize.
19. The information that entrants provide will be used by the Promoter for the purpose of conducting the Competition. By entering this Competition entrants consent to the use of their contact details for the purposes described in these Terms and Conditions.
20. Photographs will be taken at the event for marketing and media purposes. By entering this competition, the Winner consents to the use of these images, the Winner's name and suburb or property (entry) without seeking prior approval of the Winner.

Except for any liability that cannot be excluded by law, the Promoter (including its officers, employees and agents) excludes all liability (including negligence) for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Competition, including, but not limited to, where arising out of the following:
  - a. any technical difficulties or equipment malfunction (whether or not under the Promoter's control);
