This Annual Report marks more than a century in the amazing story of the City of Wanneroo which has grown from just 60 families in 1872.

When I became Mayor in 1999, we had 73,000 people. By last year, we had doubled to 149,000. It is now 160,000. By 2021, it will be 238,000 - making us the biggest local government in WA.

We are investing millions into the community - \$200m this financial year alone - and we have a 10 year plan including community buildings \$38m, parks \$31m, sports facilities \$35m, roads \$137m.

For context, in 2001 the City's operating income was \$49m. It is now \$130m. Total equity was \$380m and is now \$963m - almost a billion dollars.

We are a major City and I hope that both the State and Federal Governments will give higher priority to funding infrastructure in one of the fastest growth areas of Australia.

This is my last Annual Report as Mayor. I thank my fellow Councillors, City staff under our sterling Chief Executive Officer Daniel Simms and the whole community for your support over my 12-year term.

It is gratifying that the City has an approval rating from residents of over 80%.

I leave with the finances and administration of the City of Wanneroo in good shape and in good hands. And I wish the new Mayor and Council all the best of success. Together we have achieved a lot for our community. We can look back with pride - and forward with confidence - that the future of the City of Wanneroo will be a bright one.

From a small rural based Shire, we have grown enormously. And we should all be very proud of what we have achieved.

We have transformed Wanneroo Town Centre with \$120 million investment including - Civic Centre \$21m, Library and Cultural Centre \$18m, Aquamotion \$12m, Shopping Centre \$40m.

Huge expansion is underway in our northern corridor. Alkimos, Eglinton, Jindalee - not long ago just localities on a map - are taking shape. Yanchep eventually will be bigger than Joondalup and will become the second largest CBD outside Perth.

Citywide in the past 12 years, we have shown a commitment to families - with projects like Opportunity Playspace, Aquamotion, reserves and sporting grounds.

We have shown a commitment to seniors, providing facilities and programs. And a commitment to safer roads - investing \$180m over the past 12 years.



CEO's Message

Our 2010-11 Annual Report demonstrates our commitment to our strategic vision of delivering strong, vibrant and connected communities.

The City continued to remain the power-house of residential growth for the greater metropolitan area, creating in excess of 3,000 lots, contributing to an additional 8,000 new residents calling the City of Wanneroo home.

Council has continued to follow its adopted budget principles which have seen the City continue to improve its financial position as well as meet the strategic needs for the community and continue to improve the condition of the City's existing assets.

The City's position as a major growth corridor for Perth was further confirmed with the final adoption by the Western Australian Planning Commission of the District Structure Plans for Alkimos - Eglinton and Yanchep - Two Rocks.

The City continues to work in strong partnership with the development industry to establish creative and sustainable communities and we are grateful for their support and cooperation.

We continue to advocate strongly at a State and Federal level for investment in major transport and economic infrastructure to ensure the northern corridor is in a position to create sustainable job opportunities for its rapidly growing community. This includes the urgent need for the extension of the Mitchell Freeway and connection to the Neerabup Industrial Area and the extension of rail to Yanchep.

The City continued to attract significant investment with in excess of \$480m of development applications being received by the City and building licences for projects totalling \$752m were issued.

In addition the City has been working with owners of both Kingsway Shopping Centre and Ocean Keys Shopping Centre on major expansion projects of both these Centres - further examples of the confidence that industry has in the growth of the City of Wanneroo.

I would like to express my appreciation to our Mayor, Councillors, the City's Executive Team and Staff for their contribution and commitment to our community.

I am confident that with our responsible and prudent financial planning, an understanding of our community's needs and aspirations - together with our commitment to make a positive and lasting difference - we will continue to see both the organisation and the community of the City of Wanneroo build on our strength and social capital

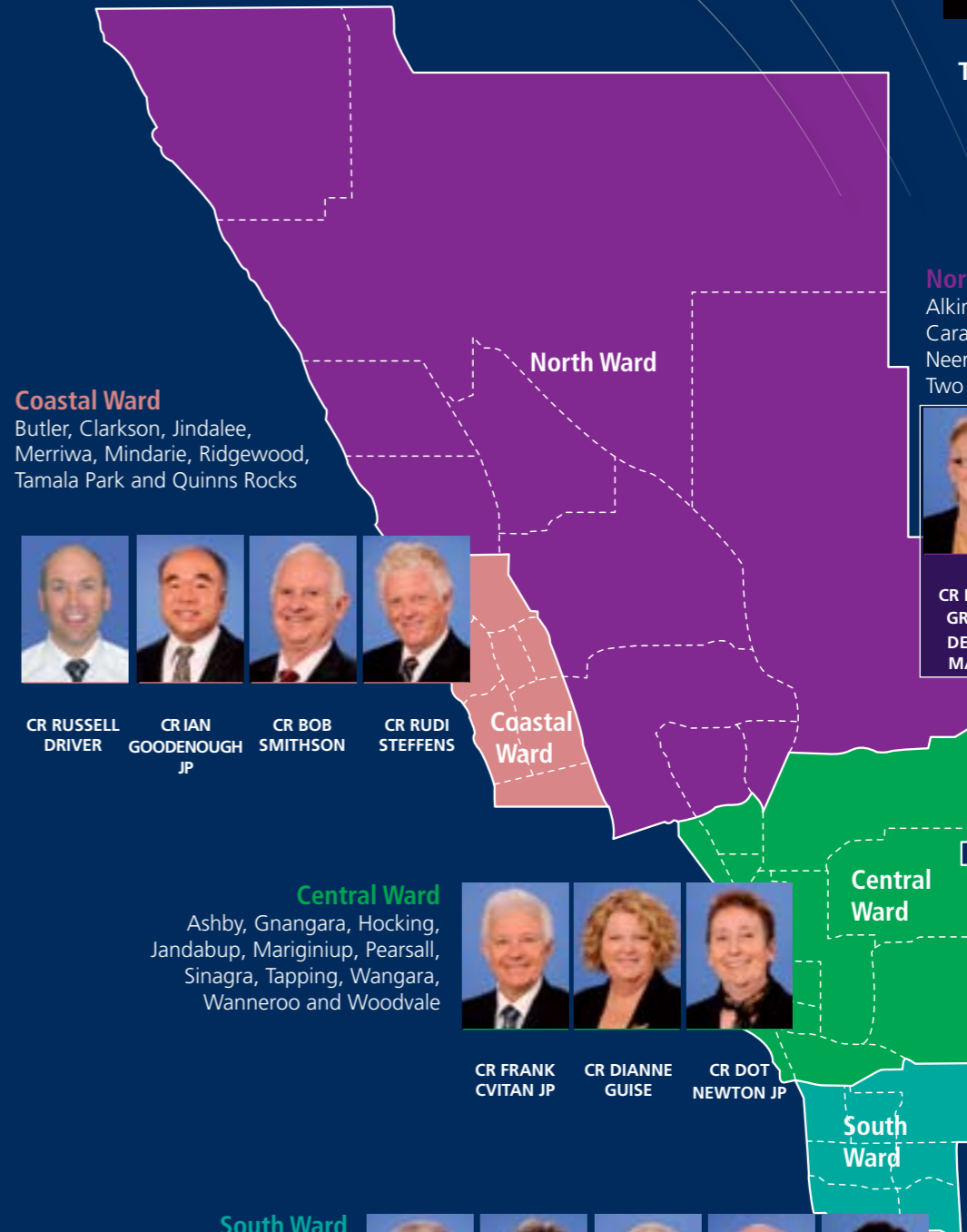

Wanneroo Profile

First recognised as a Roads District in 1902, the Wanneroo District held the first elections and Road Board Meeting in January 1903.

The City of Wanneroo is located 22 kilometres north of Perth and covers a land area of approximately 686 square kilometres. The City features large tracts of untouched bushland, State forest, wetlands, market gardens, industrial, commercial and residential estates and enjoys 32 kilometres of pristine coastline.

Economic activity is strong, with the City hosting a diverse mix of industries including agriculture, retail, construction, education, healthcare and a range of professional industries.

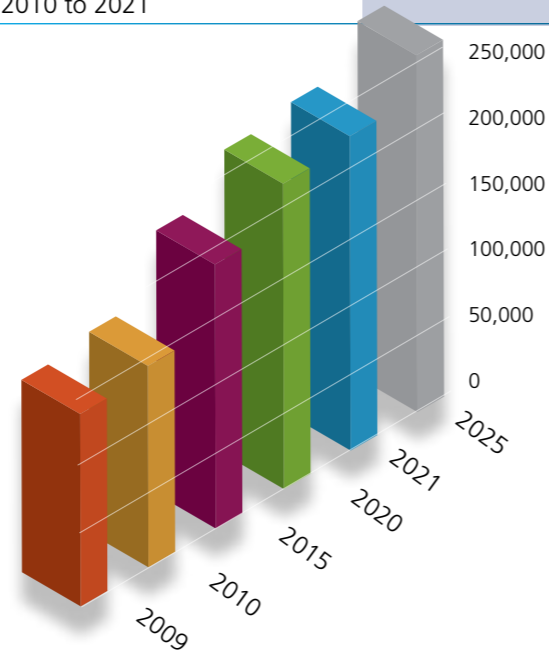

Key Achievements

The City in the 2010-11 financial year invested more than \$200 million into the community in providing infrastructure and services.

In framing our expenditure, the City factored in the real need for services and infrastructure in the City's north and coastal growth corridors while recognising the need for new and renewed facilities and services in the City's longer established central and south zones.

The total number of properties the City now services is 61,000.

The City's revised strategic plan provided the road map for the future growth and urban renewal of the City and the many communities that make up our vibrant and connected City.

This is centred around a vision for the future:

The City of Wanneroo, the centre for creative and sustainable growth delivering strong, vibrant and connected communities.

Our Annual Report complements our Community Report that can be viewed at our website wanneroo.wa.gov.au and provides a snap shot of our achievements against our strategic pillars for the reporting period.



ENVIRONMENT

A SUSTAINABLE NATURAL AND HEALTHY ENVIRONMENT

The City is investing in the rehabilitation of several sites to offset land cleared for our road network.

Stage 1 rehabilitation of environmental offset sites at Badgerup Lake and Caporn, San Teodoro, Alvarez, Spring and Appleby Parks has been completed.

Budget totals for offset works -

09/10 \$988,000

10/11 \$692,000

An upgrade of pollution controls and drainage system to the Wangara Industrial Area has been undertaken to provide a better system of control of road waste water run off, preventing it from entering Lake Joondalup.

Health Services developed a five year (2010-2015) Midge Management agreement between Cities of Wanneroo, Joondalup and Department of Environment and Conservation.

Wangara Recycling Centre processed 42,446 tonnes of recyclable material in 2010/11, an increase of 2,115 tonnes from the previous year. Materials recovered increased by 3,599 tonnes to 24,497 tonnes at a recovery rate of 58%.

The Green Waste Facility received 8,861 tonnes of waste.



ECONOMIC

A PROSPEROUS REGION ACHIEVED THROUGH ECONOMIC GROWTH AND EMPLOYMENT

Completion of the City of Wanneroo Tourism Strategy in consultation with service users and providers to attract visitors and significant investment to the City.

Continuation of the City's successful I-Lab, On-Line learning and I-Cards projects to support business.

Subdivision of Lot 2004 Mather Drive was finalised in time for sale to Western Power resulting in proceeds of \$4.3m which is to be reinvested in further development of Neerabup Industrial Area.

The City was successful in obtaining a Lotterywest grant of \$15,628 for a beach wheelchair to be located at Quinns Beach.

The Federal Government recognised the work of the City in assisting disadvantaged residents and provided \$200,000 in additional grant funding for the delivery of Commonwealth Financial Counselling. The funding is equivalent to 2 full time Financial Counsellor positions.

Over \$1 million was received from the Community Sport and Recreation Facilities Fund (CSRFF) for sporting facilities at Houghton Park, Carramar. Yanchep Regional Open Space received \$700,000 for an amenities building to be constructed.

Over \$160,000 was awarded by the Federal Government to support disability access upgrades to Opportunity Playspace and Kingsway Indoor Stadium.

Funding of \$9,488 was received for the City's first Artist Residency from the Community Arts Network (CAN WA) and also \$17,500 from the Department of Culture and the Arts for the same project.



SOCIAL

HEALTHY, SAFE, VIBRANT AND CONNECTED COMMUNITIES

The City's Centre Based Day Care (CBDC) program received \$106,300 funding for the refurbishment of Wanneroo CBDC and upgrade to the Alexander Heights CBDC to assist older adults wishing to continue living at home whilst receiving social contact with others.

The City of Wanneroo is committed to creating healthy and vibrant communities. The City received the Healthy Communities Initiative grant in 2010 from the Australian Government to rollout programs and activities to meet the health and wellbeing needs of our community.

The Healthy Communities Initiative includes a suite of programs to promote healthy, active lifestyles including walking groups, nutrition education workshops, bicycle education and much more.

The Healthy Communities Program received an additional \$577,000 funding from the Federal government with an extension of the program to 2013.

There has been improved performance of the Kingsway Indoor Stadium with continued growth in programs and overall peak period occupancy rates (80.60% for the period April to June 2011).

There has also been an increase in Aquamotion Health and Fitness memberships to a high of 1,294 and Swim School term enrolments of over 1,400.



- Replacement of irrigation system at Edgar Griffiths and Butterworth parks to provide more efficient water supply, incorporating hydrozone principles.

Kingsway Regional Sporting Complex

Under the Kingsway Master Plan, the City is investing \$22.3m over six years to upgrade the reserve including major infrastructure.

The plan is on schedule and progressing well.

- Completion of Stage 4 redevelopment of soccer and rugby fields, floodlights and upgraded car parking facilities.
- Netball Complex - renewal of western courts.
- Kingsway Master Plan review completed and adopted by Council.

COMMUNITY SAFETY

A review of the Community Safety functions of the City was undertaken and resulted in the development of an enhanced community safety model, including the re-branding of the Community Safety/Rangers fleet to provide a highly visible presence in the community.

The City conducted a Community Safety Survey, to identify community perceptions of the current Community Safety Service and to enhance this service to address the community's feedback.

Improvements have been made to the Animal Care Centre, including an exercise area and installation of partitions between kennels to reduce the risk of contamination between dogs. A permanent full-time animal care officer has been appointed and implemented improved procedures.

The Local Emergency Management Arrangements were tested by conducting a simulated bushfire desktop exercise in conjunction with FESA. The exercise identified improvements for the City's Emergency Management Arrangements and the City's Emergency Activation Flow Chart.

The City produced a bi-annual newsletter 'Paddock 2 Plate', a proactive initiative to educate and inform commercial food handlers in the City.

Health Services has also developed a free online food safety training program on the City's web.

HEALTHY LIVING

Community centre extensions, including a function area were completed at Warradale Reserve Facility.

The Yaberoo Budjara Heritage Trail: Finalisation of the interpretive signage for this trail which runs from Neil Hawkins Park to Yanchepp and beyond enables users to understand the environment in which they walk.

The City has commenced developing a Local Public Health Plan to focus on proactive preventative health strategies for the City of Wanneroo.

Infrastructure Services completed significant components of the City's arterial road network:

- Pinjar Road Realignment - Wanneroo Road to Caporn Street \$8.5m
- Hartman Drive - Gnangara Road to Hepburn Avenue \$4.4m
- Mirrabooka Avenue - Gnangara Road to Hepburn Avenue \$4.5m
- Hepburn Avenue - dual carriageway from Alexander Drive to Mirrabooka Avenue \$3.5m
- Joondalup Drive upgrade to accommodate pedestrian improvement works between Tumbleweed Drive and Old Yanchepp Road. \$1.65m

Commencement of the:

- Ocean Reef Road Extension Project from Alexander Drive to Prestige Way \$13.2m
- Joondalup Drive Dual Carriageway from St Stephens Drive to Tumbleweed Drive \$3.35m

Parks upgrade projects included:

- Barndie Park- play equipment, landscaping
- Swanley Park- development water wise park
- Old Trafford Park - creation of new park including play equipment, BMX, basketball
- New playground equipment at Avondale, Wonambie and Bardsley Parks and Wanneroo Showground.
- Construction of disabled access to the beach at Quinns Beach.
- Water - implementation of Stage 1 of the Central Irrigation Control System to better manage the supply of water to the City's parks

GOVERNANCE

LEADERSHIP AND COMMUNITY ENGAGEMENT ENSURES THE BEST OF OUR PHYSICAL, FINANCIAL AND HUMAN RESOURCES

Endorsement by Council of the Roads, Pathways and Building Asset Management Plans and the inclusion of recommended asset renewal funding in the 10 Year Strategic Financial Plan and 10 year Capital Works Program

Reviewed the City's 10 Year Financial Plan model to enhance its accountability and robustness.

Actively implemented and reviewed a range of (OSH) strategies, procedures and policies that demonstrated an improved management of OSH risks, incidents and claims costs, resulting in a reduction in premiums for 2011/12.

Cooperative monitoring of performance and budget preparation saw a significant improvement in the City's financial result for 2010/11 and allowed a budgeted Operating Surplus for 2011/12.

Improved financial performance of the Wangara Recycling Centre, Waste Operations and Kingsway Indoor Stadium - reducing Council's subsidy of these facilities.

RECONCILIATION ACTION PLAN (RAP) 2011-2013 WORKING GROUP

The City of Wanneroo is developing a Reconciliation Action Plan that will list things that the community would like to see changed or added within their community to help build better relationships and show respect for our Aboriginal and Torres Strait Islander community.

One of the key aims of Reconciliation Action Plan is to help address the inequalities experienced by Aboriginal and Torres Strait Islanders and to help close the 17 year gap in life expectancy between Indigenous and other Australians.

City of Wanneroo library services were the recipient of the inaugural Library Board of Western Australia Award for Excellence.

The City's innovative Butler Bukhara Community Kitchen was the winner of the Heart Foundation Local Government Awards 2010.



DEVELOPMENT APPLICATIONS

Over 1,300 development applications were received and determined during the last financial year covering a broad range of developments, from domestic to rural, commercial and industrial with a total value of \$480 million.

SUBDIVISION

The City supported the approval of multiple subdivision applications, that will result in the creation of 3,000 new lots throughout the City. Additionally, the City issued its 'clearance' for the actual creation of 2,656 new lots, representing the creation of over 220 new lots each month (on average) - cementing the City's place as the biggest lot generator in Western Australia and one of Australia's largest and fastest growing Councils.

STRATEGIC INITIATIVES AND MAJOR PROJECTS

During the last financial year, the City undertook a range of important strategic planning projects, including:

- Local Planning Policy 4.1: Wetlands

- Local Planning Policy 4.2: Structure Planning
- Local Planning Policy 4.3: Public Open Space

- Local Planning Policy 2.6: Ancillary Accommodation
- A major amendment to Local Planning Policy 3.1: Local Housing Strategy Implementation
- A major amendment to the City's Planning Scheme to protect key conservation reserves throughout the City

2. Preparation of:

- A Draft Coastal Management Plan (Part 1)
- Local Planning Policy 3.8: Marmion Avenue Arterial Road Access
- A Draft City Water Management Strategy and Local Planning Policy 4.4: Urban Water Management

3. Finalisation of numerous Local Structure Plans and Structure Plan Amendments.

4. Finalisation of District Structure Plans for the City's Northern Coastal Growth Corridor, comprising the localities of Alkimos-Eglinton and Yanchepp-Two Rocks. Together, the District Structure Plans cover just over 100 square kilometres and will ultimately house a resident population of more than 225,000 people at full build-out over the next 40 - 50 years.

5. Preparation of a Draft Community Facilities Plan and Development Contributions Plan for the Northern Coastal Growth Corridor, to plan for the timely and coordinated delivery of new facilities to cater for the future needs of the community in that corridor, over the next 40 - 50 years.

6. Creation of Sustainability Investment Fund by Council together with an accompanying Policy to guide expenditure of City funds on energy and water-saving initiatives to reduce costs and carbon emissions.

The Way Ahead

In this year of 2010-11, the City of Wanneroo continued to set strong foundations for the massive growth ahead. In framing our expenditure, we have factored in the real need for services and infrastructure

in the City's North and Coastal growth corridors while recognising the need for new and renewed facilities and services in the City's longer established Central and South zones.

Statutory Reports

MAJOR LAND TRANSACTIONS

SALE OF LOT 2 MATHER DRIVE, NEERABUP

Council at its Ordinary Meeting on 6 May 2008 (CS03-05/08 refers) approved the sale of Proposed Lot 2 Mather Drive, Neerabup to Western Power for a sum of \$4,237,272 plus GST with the sale to be concluded within 30 days of the issue of the certificate of title. The sale proceeded to settlement on 21 April 2011.

BUSINESS PLAN - SUBDIVISION OF LOT 506 (3) ROCCA WAY, WANNEROO

Council at its Ordinary Meeting on 3 May 2011 (CS07-05/11 refers) adopted a Business Plan for the subdivision of Lot 506 (3) Rocca Way, Wanneroo.

It is proposed that the undeveloped subdivided portion be sold to Edith Cowan University for the establishment of a GP Super Clinic and negotiations of the terms of the disposition of the land are in progress.

OTHER LAND TRANSACTIONS

LEASE - TENANCY NORTH - WANNEROO LIBRARY AND CULTURAL CENTRE

Council at its Ordinary Meeting on 24 August 2010 (CS09-08/10 refers) approved a commercial lease over an 80m² portion of the Wanneroo Library and Cultural Centre to Taryn Nanovich for Hair Salon a term of five (5) years with an option to renew for a further term of five (5) years.

LEASE - JINDALEE BEACH KIOSK - JINDALEE

Council at its Ordinary Meeting on 17 December 2010 (CS12-12/10 refers) approved the entering into a Lease with Penhurst Nominees Pty Ltd, Carine Nominees Pty Ltd and Belgravia Pty Ltd over Lot 502, being part of Crown Reserve 20561, for the purpose of developing and lease of a beach kiosk for a term of five (5) years with an option to renew for a further term of five (5) years.

LEASE - CARTRIDGE WORLD - CLARKSON

Council at its Ordinary meeting on 28 June 2011 (CS07-16/11 refers) approved the leasing of a portion of

the Clarkson Library tenancy area to L & C Perth Pty Ltd for a term of three (3) years with an option to renew for a further term of three (3) years.

EXEMPT LAND TRANSACTIONS

COMPLIANCE WITH STATE RECORDS ACT

The State Records Commission Standard 2, under the State Records Act 2000, requires a Government Organisation to include comment on the following:

- An information survey was undertaken of all information kept by the City and the results of this will form the basis of an Information Management Plan to improve the storage and retention of corporate information.
- The City received in excess of 85,000 pieces of correspondence by hardcopy and electronic means.

FREEDOM OF INFORMATION [FOI]

The City of Wanneroo operates under the Freedom of Information (FOI) Act 1992. During 2010/11, a total of twenty one (21) Freedom of Information applications were received and responded to within the regulated timeframe.

NATIONAL COMPETITION POLICY: COMPETITIVE NEUTRALITY

During the financial year, the City met its obligations under the National Competition Policy.

No competitive advantage was identified in the City's operation of Wangara Recycling Centre, Waste Operations and Wanneroo Aquamotion. The City continues to monitor Council policies and local laws for anti-competitive practices.



LOCAL LAWS

No Local laws were reviewed and amended during the reporting period.

COMPLIANCE WITH THE DISABILITY SERVICES ACT 1993 SECTION 29[2]

The City's Access and Inclusion Plan 2007-10 has been extended to March 2012 and a progress report for 2010-11 has been submitted to Disability Services Commission. The Plan forms the basis for strategic actions supporting equity of access to Council facilities, events, information and services for all people who live with a disability, their families and carers.

All Council tender documents now include a clause advising of the City's Access and Inclusion Plan, with a link to the website of the City and the Disability Services Commission. This ensures the city's external contractors understand and meet compliance requirements.

An action plan was developed for review of the City's new Access and Inclusion Plan, capturing feedback from key stakeholders in a broad community consultation process.

Milestones achieved include completion of Stage Two of Welcome in Wanneroo project, disability access information on Wanneroo Town Site and City facilities. Matting for the Beach Wheelchair project at Quinn's Beach was purchased through Lotterywest funding. The matting is a very versatile asset, easy to transport and can be used at other City events to accommodate mobility issues of community members.

Opportunity Playspace was nominated as the third top children's playspace in Western Australia in a survey by Playgroup WA to its membership throughout the State.

COMPLIANCE WITH PUBLIC INTEREST DISCLOSURES ACT 2009

There were no Public Interest Disclosures reported to the City of Wanneroo during the reporting period.

A Council Briefing Session is also held on the Tuesday of the week prior to each Council Meeting, commencing at 6pm, for the purpose of allowing Elected Members to ask questions or obtain additional information in relation to items included on the Council Meeting Agenda.

Briefing Sessions are also open to the public, and include a Public Question Time session. Public Questions at a Briefing Session must relate to an item on the current Council Agenda.



INFORMATION TO ASSIST IN THE UNDERSTANDING OF THE CONCISE FINANCIAL REPORT

The concise financial report has been prepared in accordance with AASB 1039 "Concise Financial Reports". The concise financial report, including the financial statements and specific disclosures included in the concise financial report, has been derived from the full financial report of the City of Wanneroo. A full description of the accounting policies adopted by the City is provided in the 2011 financial statements which form part of the full financial report. The accounting policies of the City are consistent with those of the previous financial year.

Rounding

Amounts shown in the Financial Statements have been rounded to the nearest dollar. This may result in minor variations between individual schedules.

Statement of Comprehensive Income

- The City raised \$81,755,406 rates revenue for the year. Additional revenue was in respect of interim rating resulting from private land developments in the City.
- The City received a significant contribution in infrastructure assets from land development activity. This is reflected in the increase in the change in net assets resulting from operations.

Statement of Financial Position

- Cash Assets at 30 June 2011 indicate an increase over those disclosed for the previous year.
- The increase in infrastructure assets is reflected in part by the increase in developer contributions.

Statement of Cash Flows

- Receipts from Rates reflects an increase over the previous year.
