# TENDER 22098: PROVISION OF BBQ CLEANING SERVICES THROUGHOUT THE CITY OF WANNEROO

#### Issue

To consider Tender No: 22098 for the Provision of BBQ Cleaning Services throughout the City of Wanneroo for an initial period of two (2) years with one (1) twelve (12) month, or part thereof, option to extend at the discretion of the City.

## **Background**

The City is seeking to appoint a suitably qualified and experienced contractor to provide regular cleaning services to the BBQ Assets located within the City's boundaries. These works are currently undertaken under contract 22059, which expires 27 August 2022.

#### Detail

Tender 22098 for the Provision of BBQ Cleaning Services advertised on Saturday 2 July 2022 and closed on Tuesday 26 July 2022. An addenda issued in response to the revised closing date extension.

## **Probity Oversight**

#### **Overall Assessment and Comment**

The tender submission from Intelife achieved the highest overall qualitative criteria ranking, satisfied the overall value for money assessment in accordance with the assessment criteria and weightings as detailed in the Procurement and Evaluation Plan, and recommends as the successful tenderer.

Intelife demonstrated extensive experience in carrying out similar contracts while confirming they have the capacity and resources required to achieve the scope of the contract. Intelife confirmed a superior understanding of the required methodology; and their evidence of safety policies and practices were of a good standard.

## **Financial and Performance Risk**

## Financial Risk

No external financial assessment was undertaken. An independent Financial Assessment undertaken for Intelife in March 2022 assessed with a 'strong' result.

#### Performance Risk

Intelife are a registered Western Australian Disability Enterprise and as the incumbent contractor has undertaken the City's BBQ cleaning requirements since 2019. Intelife has consistently undertaken all works as required in a timely manner with good communication and reporting.

## **Policy Implications**

Tenders invited were in accordance with the requirements of the City's Purchasing Policy.

## Financial (Budget) Implications

The costs associated with the Provision of BBQ services are included in the Parks and Conservation Management Annual Operational Budget. The scheduled maintenance is as per the scope and specification of the contract with fixed pricing per year. All additional works required are reactive and undertaken using the schedule of rates listed in the price schedules.

## Recommendation:

That the Chief Executive Officer, in accordance with Delegation 1.1.14 - Choice of Most Advantageous Tender of the Delegated Authority Register ACCEPTS the tender submitted by Intelife Group Limited for Tender 22098, for the Provision of BBQ Cleaning Services throughout the City of Wanneroo, as per the Fixed Pricing of \$454,907.98 (subject to appropriate funding availability for each of the financial years) within the initial two (2) year term and with one (1) further option of 12 months, or part thereof, to extend at the City's discretion.
