TENDER 22122 : PROVISION OF PARK AND STREETSCAPES MAINTENANCE FOR BUTLER EAST

#### Issue

To consider Tender No: 22122 for the Provision of Park and Streetscape Maintenance for Butler East for a period of two (2) years with one 12 month option to extend at the City's discretion.

#### **Background**

The City is seeking to appoint suitably qualified and experienced contractor/s to provide park and streetscape maintenance services to the suburb/area known as Butler East, for a period of two (2) years with options to extend at the City's discretion one (1) year term or part thereof. These works were previously undertaken against Contract No. 17158 which expired on 3 December 2022.

#### Detail

Tender 22122 for the Provision of Parks and Streetscapes Maintenance for Butler East was advertised on 8 October 2022 and closed on 1 November 2022.

All tenderers must achieve a minimum acceptable score (as determined by the City) for each of the qualitative criteria detailed above (\*) in order to be considered for further evaluation.

Pricing is not included in the qualitative criteria and is considered as part of the overall value for money assessment.

### **Evaluation Criteria 1 – Sustainable Procurement (20%)**

Evidence of Sustainable (Corporate Social Responsibility) Procurement was assessed based on the Tenderer's responses provided to the Questionnaires within Schedules 3A, 3B, 3C and 3D which formed part of the tender documentation.

#### Sub Criteria a) Environmental Considerations (5%)

The City is committed to procuring goods and services that provide positive environmental, social and economic impacts over the entire life cycle of a product or service. Respondents are encouraged to provide credentials of any environmental claims of the goods and/or services submitted in this tender.

The tender submission from Landscape Elements satisfied the overall value for money assessment in accordance with the assessment criteria and weightings as

detailed in the Procurement and Evaluation Plan and is therefore recommended as the successful tenderer.

#### **Statutory Compliance**

Tenders were invited in accordance with the requirements of Section 3.57 of the *Local Government Act 1995*. The tendering procedures and evaluation complied with the requirements of Part 4 of the *Local Government (Functions and General) Regulations 1996*.

The above risks relating to the issue contained within this report have been identified and considered within the City's strategic and corporate risk registers. Action plans have been developed to manage this risk to support existing management systems.

#### **Financial Risk**

A Credit Check returned a "strong" rating for the preferred tenderer and this was backed up by a previous assessment confirming financial capacity to meet the requirement of the contract. All payments are made on satisfactory provision of the services. Refer to the Confidential Attachment for details of the financial assessment and credit check

#### **Performance Risk**

An independent reference check was undertaken and has indicated that the recommended tenderer consistently undertakes works to a high standard. Refer to the Confidential Attachment for details of the reference check.

Prior to contract commencement, and in accordance with WHS Contract Management instructions that form part of the City's Contract Management System, a Corporate Online WHS induction will be undertaken and the Contract Start Up meeting will be utilised to validate compliance with all essential WHS requirements.

#### **Policy Implications**

Tenders were invited in accordance with the requirements of the City's Purchasing Policy.

#### Financial (Budget) Implications

The costs associated with Parks and Streetscapes Maintenance for Butler East are included/listed for consideration in the Parks and Conservation Management Annual Operational (approved and draft) Budgets. The scheduled maintenance is as per the scope and specification of the contract with fixed pricing per year. All additional works required are reactive and ad hoc and undertaken using the schedule of rates listed in the price schedules.

#### Recommendation:

That the Chief Executive Officer, in accordance with Delegation 1.1.13 - Choice of Most Advantageous Tender of the Delegated Authority Register for the awarding of tenders ACCEPTS the tender submitted by Landscape Elements for Tender 22122, for the PROVISION OF PARKS AND STREETSCAPES MAINTENANCE FOR BUTLER EAST for the Fixed Lump Sum \$539,868.39 and as per schedule of rates to the tender submission, subject to appropriate funding availability, for each of the financial years within the initial two year contract term.
