TENDER 23017: CLEANING & CCTV INSPECTION OF STORMWATER POLLUTANT TRAPS AND OTHER DRAINAGE INFRASTRUCTURE

Issue

To consider Tender No: 23017 for the Cleaning & CCTV Inspection of Stormwater Pollutant Traps and Other Drainage Infrastructure.

Background

The contract for the Cleaning of Stormwater Pollutant Traps and Other Drainage Infrastructures was introduced in 2011. Its primary purpose is to ensure a free-flowing drainage system resulting in flood prevention across the City through preventative scheduled programs.

Contract 01460 included the hire of CCTV inspections and reporting of drainage infrastructure. The initial inclusion of CCTV under the schedule was to show photographic evidence of drainage cleans, however over the years it has grown to be used as a method of capturing data to monitor the condition of drainage infrastructure.

In 2018, a further change included the hire of a CCTV Crawler camera, which allowed a detailed capture of the condition of the City's drainage infrastructure without the requirement of confined space and a non-destructive solution. The City has since begun utilising this to inspect new drainage infrastructure prior to handover from developers to the City.

Detail

Tender 23017 for the Cleaning & CCTV Inspection of Stormwater Pollutant Traps and Other Drainage Infrastructure was advertised on 11 January 2023 and closed on 25 January 2023. Two Addenda were issued in response to Tenderers queries.

All submissions were deemed conforming.

Probity Oversight

Oversight to the tender assessment process was undertaken by an external Probity Advisor (William Buck Consulting (WA) Pty Ltd) and the City's Contracts Officer. (see HPE 23/141354 for probity report).

Tender submissions were evaluated in accordance with the Procurement and Evaluation Plan (**PEP**) which included the following selection criteria:

All tenderers must meet the City's minimum requirements (as determined by the City) for each of the qualitative criteria detailed above (*) in order to be considered for further evaluation.

Pricing is not included in the qualitative criteria and is considered as part of the overall value for money assessment.

Evaluation Criteria 1 – Sustainable Procurement (20%)

Evidence of Sustainable (Corporate Social Responsibility) Procurement was assessed based on the Tenderer's responses provided to the Questionnaires within Schedules 3A, 3B, 3C and 3D which formed part of the tender documentation.

Sub Criteria a) Environmental Considerations (5%)

The City is committed to procuring goods and services that provide positive environmental, social and economic impacts over the entire life cycle of a product or service. Respondents are encouraged to provide credentials of any environmental claims of the goods and/or services submitted in this tender.

Tenderers provided details of their environmental considerations within Schedule 3A, with the following ranking:

Sub Criteria b) Buy Local (10%)

An assessment was made based on the response provided, detailing the following information:

- Location of tenderer's offices and workshops;
- Residential addresses of staff and company addresses of subcontractors;
- Purchasing arrangements through local businesses;
- Requirement for new employees arising from award of the contract.

Tenderers provided details of their "Buy Local" considerations within Schedule 3B, with the following ranking:

Sub Criteria c) Reconciliation Action Plan (RAP) (2.5%)

An assessment was made to determine the ranking based on the responses provided that relate to:

- RELATIONSHIPS building positive relationships between indigenous and non-indigenous people;
- RESPECT recognising the contribution of Indigenous people to Australia and learning more about the history, culture and diversity in a two-way communication process;
- OPPORTUNITIES attracting, developing and retaining organisational talent to build opportunities for aboriginal employment, training, and development and mentoring.

Tenderers provided information specifying differing levels of actions in relation to indigenous reconciliation action with assessment resulting in the following ranking:

Sub Criteria d) Access & Inclusion Plan (AIP) (2.5%)

An assessment was made to determine the ranking based on the responses provided that relate to:

 People with disabilities having the same buildings and facilities access opportunities as other people;

- People with disabilities receiving information in a format that will enable them to access information as readily as other people are able to access it;
- People with disabilities receiving the same level and quality of service from staff as other people receive;
- People with disabilities having the same opportunities as other people to make complaints;
- People with disabilities having the same opportunities as other people to participate in any employment opportunities.

Tenderers provided information specifying considerations for access and inclusion provisions with assessment resulting in the following ranking:

Evaluation Criteria 2 - Tenderer's Safety Management Systems (20%)

Evidence of WHS management policies and practices was assessed from the tender submissions. The assessment for safety management was based on the tenderer's responses to a specific Questionnaire included within the tender documentation.

Evaluation Criteria 3 - Tenderer's relevant experience with achievement of meeting client expectations (30%)

The tenderer's relevant experience in demonstrating the achievement of meeting client expectations as presented in their tender submission were assessed to evaluate their capability to meet the requirements of the contract. Assessment of this criterion considered the tendering entity's credentials to fulfil the requirements of the contract. The assessment of this criterion has resulted in the following ranking:

Evaluation Criteria 4 - Tenderer's resources and capacity to meet the requirements of the Contract (30%)

The tenderer's resources as presented in their tender submission were assessed to evaluate their capacity to meet the requirements of the contract. Assessment of this criterion considered the tenderer's staff resources, vehicles, plant/equipment and workshop support to manage the contract. The assessment of this criterion has resulted in the following ranking:

Pricing for the Goods and Services

An assessment was made to determine the ranking based on the schedule of rates provided with the tender documentation. As Cleanaway did not achieve the minimum acceptable score for all relevant criterion they did not progress to the Price and Value for Money assessment.

Overall Assessment and Comment

The tender submission from Drainflow Services satisfied the overall value for money assessment in accordance with the assessment criteria and weightings as detailed in the PEP and is therefore recommended as the successful tenderer. Drainflow Services submission assessed as having suitable safety systems, experience, resources, capacity and a proven methodology to carry out the requirements of the contract.

Tenders were invited in accordance with the requirements of Section 3.57 of the *Local Government Act 1995*. The tendering procedures and evaluation complied with the requirements of Part 4 of the *Local Government (Functions and General) Regulations 1996*.

The costs associated with the Cleaning & CCTV Inspection of Stormwater Pollutant Traps and Other Drainage Infrastructure are included in the Asset Maintenance Operational Budget.

Recommendation:

That the Acting Chief Executive Officer, in accordance with Delegation 1.1.13 - Choice of Most Advantageous Tender of the Delegated Authority Register for the awarding of tenders ACCEPTS the tender submitted by Drainflow Services Pty Ltd for Tender 23017, for the CLEANING & CCTV INSPECTION OF STORMWATER POLLUTANT TRAPS AND OTHER DRAINAGE INFRASTRUCTURE, as per the schedule of rates in the tender submission for a period of one (1) year with one (1) twelve month, or part thereof, option to extend at the discretion of the City and subject to appropriate funding availability, for each of the financial years within the contract term.
