TENDER 23134 THE SUPPLY AND INSTALLATION OF NEW WATER SERVICE, FIRE SERVICE AND SEWER SERVICE AT THE KINGSWAY REGIONAL SPORTING COMPLEX, MADELEY

#### Issue

To consider the decline of Tender No: 23134 for the Supply and Installation of New Water Service, Fire Service and Sewer Service at The Kingsway Regional Sporting Complex, Madeley.

## **Background**

Kingsway Regional Sporting Complex is an active sporting reserve located at 100 Kingsway, Lot 555, Madeley. The portion of land selected for this project is in the north east corner, adjacent to the Kingsway Air Cadets and is on the corner of Hartman Drive and Kingsway.

A car park and access road are to be constructed to provide parking and access to several proposed buildings including the Northern Suburbs Men's Shed. The buildings will also require hydraulic services to be installed to service the new buildings.

#### **Detail**

Tender 23134 for the Supply and Installation of New Water Service, Fire Service and Sewer Service at The Regional Kingsway Sporting Complex was advertised on 1 November 2023 and closed on 12 December 2023. Two addenda were issued during the tender period to provide additional information to Tenderers, and mandatory site inspections were held.
