- 3. Modify Section 2.0 Structure Plan Content: under (a) replace the words "Statutory Planning Section" with "Implementation."
- 4. Modify Section 4.0 Operation Date as follows:

In accordance with sub-clause 9.8.1 of the Scheme, this structure plan shall come into operation on the later date of when it is either certified by the Western Australian Planning Commission pursuant to sub-clause 9.6.3 of the Scheme, or adopted, signed and sealed by the Council under sub-clause 9.6.5 of the Scheme

PART 2 - EXPLANATORY REPORT

AMENDMENT NO. 10 TO THE

EAST WANNEROO CELL 9 – EAST LANDSDALE APPROVED STRUCTURE PLAN NO. 57

This amendment to East Wanneroo Cell 9 East Landsdale Cell 9 - Approved Structure Plan No. 57 seeks to:

- a) update the Structure Plan such that it is consistent with the provisions of the *Planning and Development (Local Planning Schemes) Regulations 2015* and the weight given to a structure plan;
- b) modify the Structure Plan to modify/delete provisions that will be incorporated into Scheme Amendment 146 which provides for the introduction of Special Control Areas and specifically Special Control Area 2 relating to the area subject of East Wanneroo Cell 9, East Landsdale - Approved Structure Plan No. 57.

The amendment seeks to clarify the standards and requirements that were contained in East Wanneroo Cell 9, East Landsdale - Approved Structure Plan No. 57 that have been transferred to the Scheme through the introduction of SCA2 under Schedule 17: Special Control Areas.

This amendment to East Wanneroo Cell 9, East Landsdale - Approved Structure Plan No. 57 (ASP57) is considered to be minor in nature in that it does not propose any new or additional requirements to the Structure Plan, it simply updates the structure plan to be in accordance with the *Planning and Development (Local Planning Schemes) Regulations 2015* and provides clarification as to what provisions of East Landsdale Cell 9 - Approved Structure Plan No. 57 are now contained in the Scheme under Schedule 17 and the provisions of Special Control Area 2. Scheme Amendment 146 has been advertised and the submission received in regard to that Amendment was addressed and the Scheme Amendment modified accordingly.

Amendment 10 to ASP57 does not introduce any new provisions to the Structure Plan and Scheme Amendment 146 has been advertised, however, the Western Australian Planning Commission has advised that this amendment to the Structure Plan is required to be advertised.

Amendment 10 to ASP57 should be considered concurrently with Scheme Amendment 146. As Amendment 10 to ASP57 seeks to remove subdivision and development standards from ASP57 and incorporate such standards into the Scheme via Amendment 146, therefore, Amendment 10 to ASP57 should not be certified by the Western Australian Planning Commission until such time as Amendment 146 is gazetted.
