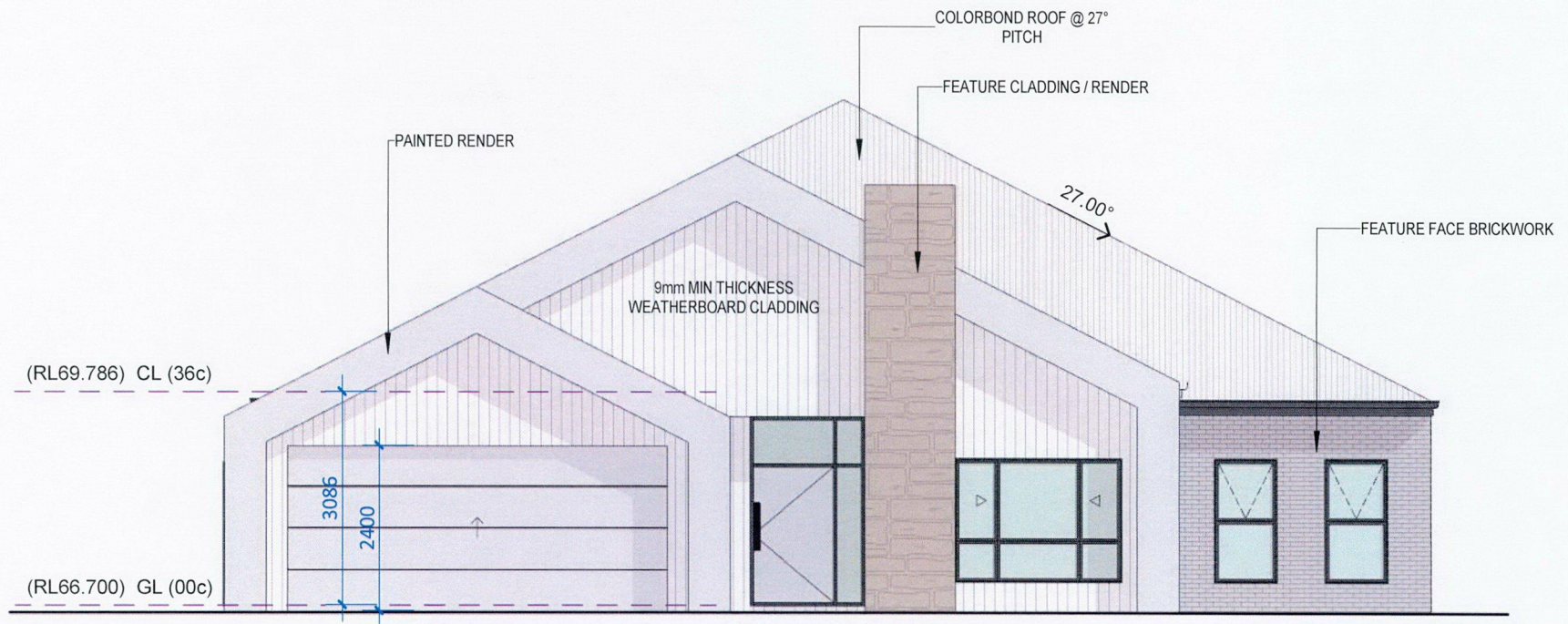

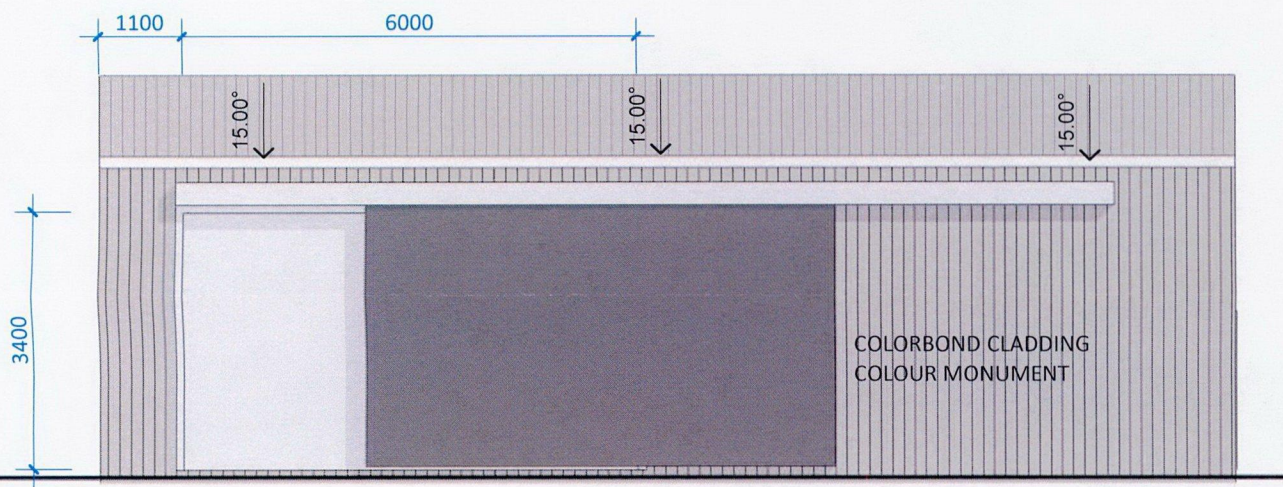
**E3** North Elevation

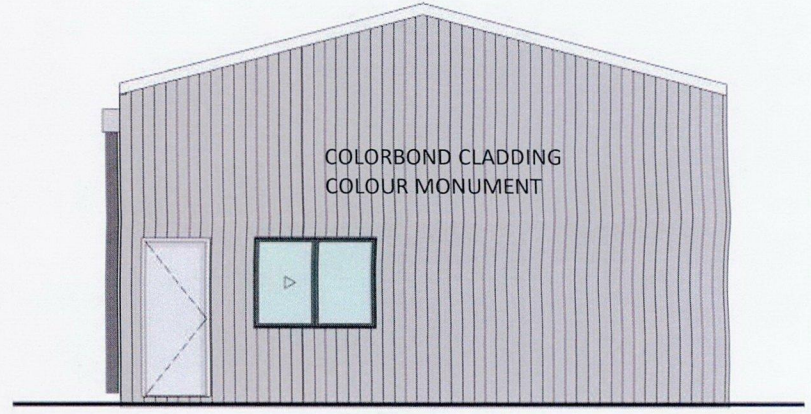
**E4** South Elevation

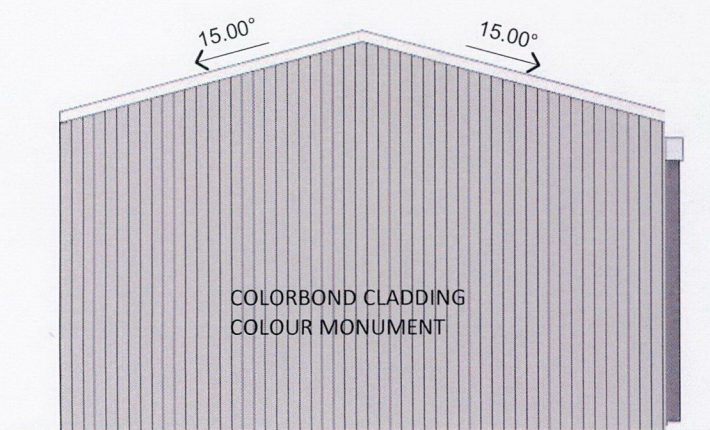
1 Shed Plan

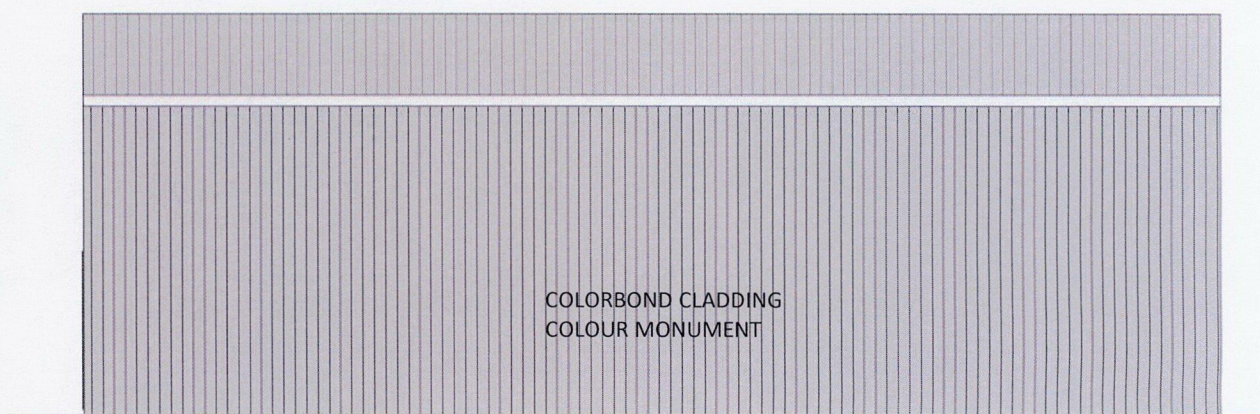
E1 Shed East E

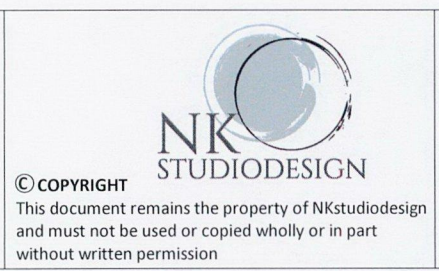
