

Public Places and Local Government Property Local Law 2015

This Form is to be used for the purposes of obtaining a trading licence under the City of Wanneroo's Public Places and Local Government Property Local Law 2015. Applications should be lodged at least 2 weeks prior to trading commencement to allow sufficient time for processing. Applications providing insufficient information or less than 2 weeks notice may be refused.

This Form is not required to trade at an approved event on Council land or private property. Food vendors wishing to trade at approved events should complete the Food Notification and Registration Form, unless already registered/notified.

Site plan – Non Food

Individual traders - Provide site plan of stall location (for new applications or if different from last time). Include details such as: type of stall structure e.g. table/marquee/van (include rego) and fixtures and fittings, types of goods being sold and any equipment being used.

Site Plan - Food Vendors

Food Vendors - provide details of stall/vehicle including type of foods provided, type of stall structure e.g. table/marquee/van (include rego) and fixtures and fittings, hand basin, sink(s), cooking equipment, refrigerator etc.

Important Information on food traders:

Food businesses wishing to operate under this Trading Licence must be classified as exempt under the *Food Act 2008* or hold a Registration Certificate. An exempt food business is exempted from registration only. They are still required to comply with the remaining requirements of the *Food Act 2008* and *Australia New Zealand Food Standards Code*. In particular they must have provided Notification to the Local Authority. For each exempt food business operating under this licence a 'Food Business Notification and Registration Form' is to also be submitted to the City. Where notification has previously been provided a copy of any notification acknowledgement from the Local Authority may be provided instead. Businesses holding a Registration Certificate should include a copy of the certificate.

Types of Exempt food business:

- Food business is a charity or community group not involving the handling of potentially hazardous food (PHF - food requiring temperature control to prevent the growth of pathogenic microorganisms or the formation of toxins).
- Food business is a charity or community group whereby food is for immediate consumption after being appropriately cooked e.g. sausage sizzle.
- Food business consists solely of selling food that is not potentially hazardous food and is contained in a closed package so that it cannot be handled in the course of conducting the food business e.g. lollies, chocolate .
- Food business consists solely of providing complimentary drinks in conjunction with another business conducted at those premises.

Payment of Fees (to accompany application):

Charities, Community Groups and Not For Profit Organisations are exempt from paying these fees. New applications are to pay both an application fee and a pro rata licence fee whereas an existing licence renewal is to pay only the licence fee.
