


Information Statement Freedom of Information Act 1992

This document has been prepared and published in accordance with the requirements of Part 5, *Freedom of Information Act 1992*. Section 94 of this Act requires each agency to prepare an Information Statement.

The City is committed to open and accountable government. Access to information held by the City is available from the City's libraries, offices, website, telephone, email or by post.

- Agenda Briefings are held on the second Tuesday of each month commencing at 6:00pm
- Ordinary Council Meetings are held on the fourth Tuesday of each month commencing at 6:00pm.

There will be no meetings during October 2025 due to Local Government Elections.

The City retains a wide range of documents dating back to the 1960s that result from its business including plans, approvals, budgets, notices, strategies and reports. These documents are in many formats (e.g. paper, microfiche and digital).

In accordance with the City's Records Management Policy the official record of the City is electronic. Efforts are being made to change processes and storage of documents to reflect this new electronic record format. Many older documents whose processes have not yet changed will retain their original format.

The City has no procedures for amending personal information under the FOI Act. Any application to amend personal information will be dealt with in accordance with Part 3 of the FOI Act.
