



## EYES ON THE STREET

Having 'eyes' on the street, watching the environment so abnormalities can be addressed.

### Key Action Areas

- » Apply urban and environmental design principles to reduce the opportunity for crime and maximise personal safety.
- We use of CCTV as a surveillance measure to reduce the incidence of antisocial behaviour.
- "Eyes on the Street' A coordinated intelligence gathering initiative that encourages and enables agencies to identify suspicious people, vehicles and / or activities.
- » Regular Ranger and Safety patrols act as the 'eyes and ears' of the City and are a vital part of helping to make the community a safer place.

# TARGETING PRIORITIES

## EMERGENCY MANAGEMENT

Planning ahead can prevent and minimise loss to human life, wildlife, the environment and property. Having strategic bodies and plans in place help safeguard our community and your welfare.

#### Key Action Areas

- Didentify strategies to prevent or mitigate the risks created from natural and manmade hazards that may be reasonably expected to impact the City.
- Develop and maintain local emergency activation flowchart (LEAF), local emergency management arrangements (LEMA) and recovery plan.
- Ensure local emergency management arrangements, recovery plans and partnering agreement are continually updated.

#### Outcomes

- Prevent / reduce the City's risk of an emergency where necessary.
- Increase the City's preparedness in the event of an emergency.
