COMMUNITY CONSULTATION TRAFFIC MANAGEMENT TREATMENTS – ANCHORAGE DRIVE (SOUTH)

The City is planning to install traffic management treatments on Anchorage Drive (south) and would value your feedback on what is proposed. This letter provides some background and details of the planned scheme, to make it easier for you to provide your comments.

The proposed traffic management scheme involves the installation of painted cycle lanes between Rosslare Promenade and Swansea Promenade/Honiara Way and planting trees in the existing median between Swansea Promenade/Honiara Way and Ocean Falls Boulevard.

The reduction in road width achieved by installing cycle lanes may be effective in reducing vehicle speeds which in turn leads to safer roads. While it is expected that the impact in reducing vehicles speeds may be less than other traffic treatments, the installation of cycle lanes will cause minimal disruption to surrounding residents in terms of additional traffic noise, and the associated tree planting can create a closed environment and encourage voluntary reduction in vehicle speed.
