

## Race in your Rates 2016

### Terms and Conditions

1. This Competition is a promotion run by the City of Wanneroo ("Promoter").
2. Entries and information on Prizes and how to enter form part of these Terms and Conditions.
3. Participation in this Competition constitutes acceptance of these Terms and Conditions.
4. Employees of the Promoter and their immediate families are ineligible to enter.
5. Entry to this Competition is open to ratepayers of the City of Wanneroo who either pay their City of Wanneroo rates:
  - a. in full; or
  - b. in instalments (whether electing to the two instalments or the four instalments option as listed in their 2016 City of Wanneroo rates notice), with the first instalment paid, on or before 4pm WST on Monday 5 September 2016.
6. Payment must be received on or before 4pm WST on Monday 5 September 2016 to be eligible. No responsibility is accepted for late, lost or misdirected payments.
7. The Major prize is only open to residents who pay their rates in full on or before 4pm WST on Monday 5 September 2016. All other prizes will be open to residents who pay their rates in full or pay the first instalment on or before 4pm WST on Monday 5 September 2016.
8. The Competition commences Monday 1 August 2016 and closes at 4pm WST on Monday 5 September 2016 ("Competition Period"). The Competition draw will take place at 2pm on Friday 9 September 2016 at the City of Wanneroo's Civic Centre, 23 Dundobar Road, Wanneroo WA 6065.
9. Eleven winners will be chosen at random from a database of all eligible rate payments received ("Winner/s").
10. The Promoter's decision in relation to all aspects of this Competition is final and binding on all who enter and no correspondence will be entered into.
11. The eleven Winners will be required to attend a Prize presentation function at the City of Wanneroo Civic Centre where they will draw at random one of eleven Prizes. Winners or their nominated representative (as communicated to the Promoter prior to the Prize presentation function) must present a valid form of photographic identification upon collecting their Prize. Each Winner receives only one Prize.
12. The eleven Prizes consist of a total value of \$15,135.50 and comprise of ("Prize"):
  - a. Major prize - one \$5,000 Travel Voucher for Flight Centre, Wanneroo to be redeemed by expiry date. Total value of \$5,000. The Winner is responsible for the payment of any taxes, fees, charges, visas or passports associated or required to redeem this Prize;

Location and necessary permits/approvals for desired location to be organised by winners. Dates are subject to availability, early booking recommended.   - e. two Mindarie Marina overnight spa suite stays to be redeemed by expiry date. Dates subject to availability blackout dates may apply. The two Prizes will be awarded to two different Winners. Each individual Prize is valued at \$550;
  - f. two \$1000 Coles Myer gift cards to be redeemed by expiry date. The two Prizes will be awarded to two different Winners. Each individual Prize is valued at \$1000;
  - g. two \$500 Coles Myer gift cards to be redeemed by expiry date. The two Prizes will be awarded to two different Winners. Each individual Prize is valued at \$500;
13. Prize components may alter at the discretion of the Promoter. The Promoter will not be liable for any change in the value of any Prize between the date Rates Notices are issued and the date Prizes are claimed.
14. Prizes are not transferable, refundable or redeemable for cash.
15. Prizes are subject to availability and all other relevant Terms and Conditions.
16. The Winners will be notified by phone, email or mail of their entry into the Race in your Rates Prize presentation function and sent a formal invitation to attend the function. If a Winner cannot attend or send a representative to the Prize function, they will forfeit their Prize and it will be redrawn upon the conclusion of the function. Competition results will be published on the City of Wanneroo's website.
17. The Promoter will redraw the Prize until a suitable Winner has collected their prize. The Winner must collect their Prize by 9 December or it will be judged forfeited.
18. The Promoter will not be liable for any delivery or travel costs associated with claiming a Prize.
19. The information that entrants provide will be used by the Promoter for the purpose of conducting the Competition. By entering this Competition entrants consent to the use of their contact details for the purposes described in these Terms and Conditions.
20. Photographs will be taken at the Prize presentation function for marketing and media purposes and the Winners consent to the use of these images, the Winners' names and suburb or property without seeking prior approval of the Winner.

Except for any liability that cannot be excluded by law, the Promoter (including its officers, employees and agents) excludes all liability (including negligence) for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Competition, including, but not limited to, where arising out of the following:
  - a. any technical difficulties or equipment malfunction (whether or not under the Promoter's control);
  - b. any theft, unauthorised access or third party interference;
  - c. any entry or Prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter;
  - d. any variation in Prize value to that stated in these conditions of entry;
  - e. any tax liability incurred by a Winner or entrant;

- f. participation in the Competition; and/or
  - g. redemption of the Prize, and
