Until such time, the City of Wanneroo shall be entitled to rely on the details contained in this application.
- 3. The person signing this application warrants that he/she and the Vendor have full authority and power to enter into this agreement and that the details in this application are true and correct. The City of Wanneroo is under no obligation to verify any of the details contained in this application or the authority of the person who signed this application.
- 4. The Vendor acknowledges that the details set out in the completed application must be made available to the City of Wanneroo staff in order to facilitate EFT payments.
- 5. The City of Wanneroo will not be responsible for any delays in banking systems in respect of the EFT payments.
- 6. The City of Wanneroo is not bound to accept this application.
- 7. Either party may at any time, by at least 7 days written notice to the other party, terminate the agreement.
