

#### **PROFESSOR ROBERT CERVERO**

Professor Robert Cervero, the current Emeritus Professor of City and Regional Planning at the University of California Berkeley, is a worldrenowned global thinker who has advised governments across the world with respect to integrating economic development with land use and transport linkages for optimum results.

Professor Cervero currently works in the area of sustainable transportation policy and planning, focusing on the nexus between urban transportation and land-use systems. He is Freisen Chair of Urban Studies as well as Director of the University of California Transportation Center (UCTC), a multi-campus research centre devoted to advancing economic competitiveness, sustainability and livability. His current research focuses on the intersection of infrastructure, place-making and economic development.

Professor Cervero has, and continues to serve as an advisor and consultant on numerous transport and urban planning projects worldwide and has frequent requests to assist governments and the private sector. He is the first ever recipient of the Dale Prize for Excellence in Urban Planning Research and is a two-time recipient of the Article of the Year Award from the Journal of the American Planning Association. In 2013 he was ranked among the top 100 City Innovators Worldwide by UMB's Future Cities.



#### **ADAM BECK**

Adam is Founding Executive Director of Smart Cities Council Australia New Zealand, Cities Advisor to the Green Building Council of Australia, and Director of Centre for Urban Innovation, a consulting practice collaborating with urban leaders to build sustainable communities and cities.

Adam is also an ambassador with Portland-based think tank EcoDistricts, where he was previously Director of Innovation. Before entering the non-profit world, Adam spent almost a decade with global consulting firm Arup, and five years with GHD.

Adam was also lecturer and studio lead in social impact assessment and community engagement at the University of Queensland, and maintains strong research interests in collaborative governance processes for city-building.
