Conditions of Burning undertaken by the City of Wanneroo's Volunteer Bush Fire Brigades

1. This request is valid for Twelve (12) months from issue by the City of Wanneroo's Volunteer Bush Fire Brigades.
2. The Property Owner acknowledges their responsibility to perform any site works deemed necessary by the City of Wanneroo's Volunteer Bush Fire Brigades prior to the commencement of Burning.
3. The Property Owner acknowledges their responsibility to notify the owners and tenants of properties adjacent to that property, which is to be burnt, of the approximate time of ignition and the approximate time of completion of said burn.
4. This form does not constitute or imply any undertaking by the City of Wanneroo's Volunteer Bush Fire Brigades to carry out any hazard reduction burning, and this document is in no way a contractual agreement to perform that said burn.
5. Hazard reduction will remain the responsibility of the property owner.
6. The City of Wanneroo's Volunteer Bush Fire Brigades reserves the right to refuse to carry out the requested hazard reduction burn.
7. Whilst every endeavor will be made, no guarantee will be given by the City of Wanneroo's Volunteer Bush Fire Brigades to perform or complete the Hazard reduction burn on the day nominated (which is given as an estimate only). City of Wanneroo's Volunteer Bush Fire Brigades will not be responsible for any cost or consequential expenses to the property owner arising from delays in respect of the completion or commencement of hazard reduction burning.
8. Upon completion of the hazard reduction burn, the City of Wanneroo's Volunteer Bush Fire Brigades and the owner acknowledge and agree that all responsibility and liability in connection with the property and the hazard reduction burn reverts back to the owner.

By signing this form, I, the Property Owner, confirm that I accept the Conditions of burning undertaken by City of Wanneroo's Volunteer Bush Fire Brigades and that I accept full responsibility (and any associated liability) in connection with my property and the hazard reduction burn undertaken on my property after the completion of the hazard reduction burn and departure of the City of Wanneroo's Volunteer Bush Fire Brigades from my property.
