RESIDENTIAL VEHICLE CROSSOVER SUBSIDY

Congratulations on the recent approval to construct your new house. As construction will soon commence, the City wishes to take this opportunity to remind you about your obligation to construct a suitable vehicle crossover once your house is built.

It is important that the crossover meets the City's requirements and as an incentive, the City will offer a subsidy to those owners who have directly incurred a cost for the construction of their first crossover. The amount of subsidy is fifty percent (50%) of the total construction cost up to a maximum amount of nine hundred and eighty five dollars and seventy cents (\$985.70).

To be eligible to apply for this subsidy the attached Statutory Declaration must be completed and returned to this office together with an <u>itemised receipt</u> confirming your payment.

The Statutory Declaration is a legally binding document; therefore, it must be completed correctly.

The Statutory Declaration must include:

 \checkmark The Owner(s) Name, Address and daytime contact number indicated on the top section of the Declaration. (All owners must complete the Declaration)

 \checkmark The construction cost of the vehicle crossover, including labour, which is to be indicated in section 4 of the Declaration.

 \checkmark A copy of an itemised receipt indicating proof of construction value and/or a receipt for construction materials and/or a letter of confirmation of construction and cost from Builder. If providing an invoice, this must be stamped "paid in full" and signed by the Builder.

 \checkmark The owner(s) signature in the bottom right section of the Declaration.

 \checkmark A competent witness declaration as indicated on the rear of the Statutory Declaration. This competent witness is to sign and declare on the bottom left of the declaration. Owner(s) must not sign the Declaration without the competent witness being present.

✓ Declaration that the crossover was constructed *within six (6) months* of the date of this Declaration.

Owners must ensure the crossover is installed according to Council's Vehicle Crossover Specification which can be found on the City's website at <u>www.wanneroo.wa.gov.au</u>. The subsidy is for <u>CONCRETE or BRICK</u> <u>PAVING</u>; Liquid Limestone or any other materials which are not mentioned in the City's Crossover Specifications <u>will not</u> be considered for a Subsidy.

It should be noted that the City only offers this subsidy for the construction of the first vehicle crossover to a property. Construction of additional vehicle crossovers or reconstruction of an existing complying crossover is not eligible for the subsidy.

Subsidy claims will also not be approved if the crossover construction has occurred prior to <u>six months</u> of the application for the crossover subsidy date. If you have a pre-existing subdivisional crossover, you are not eligible for the subsidy unless a receipt confirming your payment for the crossover and statutory declaration is provided.



Competent Witnesses

Persons who may witness statutory declarations in Western Australia:

- 1 The Chief Executive Officer or Deputy Chief Executive Officer of a Local Government.
- 2 A member of the Council of a Local Government.
- 3 An Electoral Registrar appointed under the Electoral Act 1907.
- 4 A person appointed to take charge of a Post Office in the State
- 5 An Officer of the State or Commonwealth Public Service.
- 6 A teacher within the meaning of the Education Act 1928.
- 7 A Police Officer
- 8 A person appointed to take charge of the head of any branch office in the State of a Bank carrying on business under the Banking Act 1959 of the Commonwealth or under a written law of the State.
- 9 A person appointed to take charge of the head of any branch office in the State of a Society within the meaning of the Building Societies Act 1976 or a Credit Union within the meaning of the Credit Unions Act 1979.
- 10 A secretary of an organisation of employees or employers registered under the Industrial Relations Act 1979 or of an organisation registered under the Conciliation and Arbitration Act 1904 of the Commonwealth.
