## Your Rates Notice explained

- The period this notice covers.
- This is the individual number allocated to the property that this notice is related to.
- This is the lot number and address of the property.
- This is the date the notice was produced.
- This is the property owner's name and mailing address.
- A breakdown of City of Wanneroo rates and services charges, and State Government charges.
- This is your property's Gross Rental Value (GRV) or Unimproved Value (UV) and is calculated by the Valuer General's Office (Landgate). If you object to this value please phone Landgate on (08) 9273 7373.
- The rate in the dollar determined by the City. This is multiplied by your valuation to determine your rates amount.
- This relates to any arrears on your account.
- This is your rates for the current year.
- The total amount you are required to pay.
- The amount you have to pay and the due date. There are four options; a full payment, two instalments, four instalments or five instalments.
- This is your reference number. You should quote this number when you contact the council about your account.
