

CCTV Rebate Program

Definitions

Applicant means a person making an application for a CCTV System Rebate.

CCTV System means a Closed-circuit television system, also known as video surveillance.

CCTV Rebate means the rebate an applicant may be eligible for after making an application for CCTV System Rebate.

Security Agent Licence means a person holding a current licence authorising the supply of services by a Security Installer, under the provisions of the Security Related Activities (Control) Act 1996.

Security Installer means a person currently licenced to install security equipment under the provisions of the Security Related Activities (Control) Act 1996. List of current licence holders can be downloaded from the WAPOL website following the "Security Installer" link: https://www.police.wa.gov.au/About-Us/Our-agency/Police-Licensing-Services/Security/Current-licence-holders.

The City means the City of Wanneroo.

Terms and conditions

- 1. The CCTV System must be installed at a property within the City by a current Security Installer Licence holder and must be a registered business with a Security Agent Licence in accordance with the Security Related Activities (Control) Act 1996.
- 2. The CCTV Rebate is only applicable to newly installed CCTV Systems installed after receiving pre-approval from the City.
- **3.** At least one camera must overlook public places such as roads, footpaths, front verges, parks or laneways. Properties with a limited view of public places may not be eligible for the CCTV Rebate.
- **4.** The CCTV System must be installed in accordance with the *Surveillance Devices Act* 1998. The camera field of view must not overlook neighbouring private property such as backyards, view of windows, etc. An Applicant must inform its neighbours if their property or activities are visible in the camera's field of view.
- **5.** The CCTV System must have:
 - a. Hard-wired cameras
 - b. 6-megapixel resolution
 - c. A 3-terrabyte hard drive
 - d. Night-time capability; and
 - e. Time/ date displayed on screen.
- **6.** The CCTV System must be registered with the WA Police Force State CCTV Register Cam-Map WA prior to submitting a claim for payment.
- 7. The Applicant agrees to provide footage to the WA Police when requested by the Police.
- **8.** The City will make a once off CCTV Rebate. The payment may be up to 30% of the cost excluding GST for the installation of the CCTV System. Such payment will however be limited to \$500.00. The final rebate amount will not be more than the pre-approved amount if installation cost increases but may reduce if the installation cost is less than the

- submitted quote amount. The CCTV Rebate amount will be determined by the City at its sole discretion.
- **9.** Before installation the Applicant must provide the City with photos showing the public facing camera(s) proposed field of view.
- **10.** Within 60 days of City pre-approval, the CCTV System must be installed in accordance with these Terms and Conditions. All required documentation should be submitted to the City of Wanneroo within 14 days of the installation completion.
- **11.** The CCTV System must be fully paid for, and all forms must be completed in full before the CCTV Rebate payment is made.
- 12. The CCTV System must be kept in working order.
- **13.** If the Applicant is not the property owner, the property owner or agent must give its written consent to have the CCTV System installed before the Applicant applies for a CCTV Rebate. This consent must be provided with the pre application.
- **14.** An Applicant must inform its neighbours if their property or activities are visible in the camera's field of view.
- **15.** One application per property will be considered each Financial Year.
- **16.** CCTV systems that have received funding from this program in previous Financial Years are not eligible for funding in future years.
- 17. Applicants must not have a current outstanding debt with the City.
- **18.** The City may at is discretion approve or refuse an application for a CCTV Rebate for any reason it thinks appropriate.
- **19.** The City reserves the right to cancel CCTV Rebate arrangements at any time if the above Terms and Conditions have not been met.
- **20.** The City is not and will not be liable for any costs incurred or loss suffered by the Applicant in relation to the installation of a CCTV System.
